For any water tap over four (4) inches, the connection fee shall be negotiated by the City Administrator, according to existing conditions at the time of the request for such connection. Any unit or patron served by the City outside the corporate limits shall be charged double the plant investment fees indicated in this section and said unit or patron must enter into a contract approved by the governing body prior to the tapping of the City water main. Delivery of water to the user by the City shall, in all instances, terminate at the City limits.
